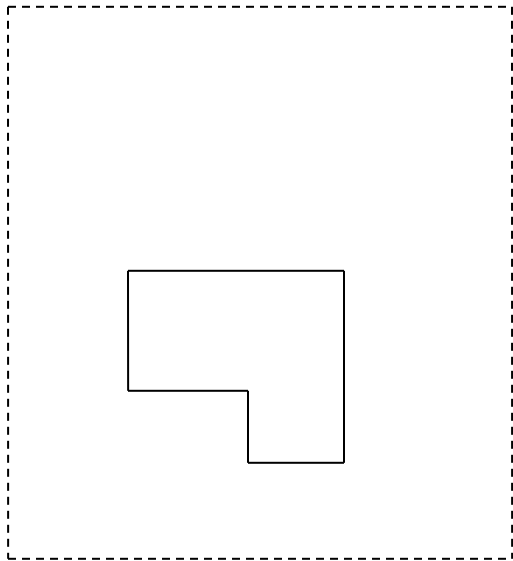
- i) drawing scale;

- iv) existing and proposed construction dimensions;
- v) setbacks and lot lines;
- vi) any proposed changes to grade;
- vii) type of Swimming Pool to be installed;
- vii) safety measures to be taken during all aspects of construction.

## **SWIMMING POOL PERMIT PROVISIONS**

---

### **Zoning By-Law Setbacks**

- ✓ **Interior Side and Rear Yard ONLY**
  
- ✓ **INTERIOR SIDE/ REAR YARD SETBACKS**
  - Side lot line = 1.2 meters (4ft)
  - Rear lot line = 1.2 meters (4ft)
  - Primary building (house) = 2 meters (6.5ft)

---

### **Pool By-Law Requirements**

- ✓ Nothing within 1 meter (3.3 ft) of the fence (includes deck and/or hardscape)
- ✓ Fence 1.2 meters (4ft) from waters edge
- ✓ Fence 1.5 meters (5ft) tall
- ✓ No gaps in fence bigger than 10 cm (4in)
- ✓ Maximum clearance between bottom of fence and grade 10 cm (4in)
- ✓ Gate must be self latching

### **IMPORTANT**

IN ORDER TO KEEP YOUR POOL PERMIT CURRENT AND ACTIVE, YOU MUST CALL TO BOOK AN INSPECTION OF THE POOL AND THE ENCLOSURE PRIOR TO PLACING WATER INTO THE POOL
