

How to Apply for a Pool Enclosure Permit Application

The Township of Scugog is pleased to offer Cloudpermit to book a pool enclosure permit.

How do I apply for a Pool Enclosure Permit?

Creating and submitting applications on Cloudpermit through the Township of Scugog is quick and easy. To do so, you'll need to follow a few steps outlined below. Cloudpermit & the Township of Scugog will instruct you how to complete and submit the application. Once submitted, it will be reviewed. Look out for communication emails back to keep your application on track with review and processing. Final issued permit will be available for you to download from Cloudpermit, located on Township of Scugog's website.

Step 1: Start creating a new application by clicking the button 'Create your first application'.

Step 2: Invite other necessary parties, such as property owner or contractor.

Step 3: Complete your application, upload all required documents.

Step 4: Verify, Sign and Submit for review.

Step 5: Once the completed application is received you will be invoiced and pay the fees either online or over-the-counter.

Step 6: Revise the application based on the feedback from the Township of Scugog.

Step 7: Watch for follow up emails to make sure the process keeps going.

Step 1: Start creating a new application by clicking the button 'Create your first application'.

To Start a New Pool Enclosure Permit Application **Register** to Cloudpermit: <u>https://ca.cloudpermit.com/registration</u> **Login** to Cloudpermit: <u>http://ca.cloudpermit.com/login</u>

Register for an account for new users and click on confirmation email. Set a strong password and enter fields as required.

Click the "Create your First Application" button.

Create a **New Project** and give it a name. Some combination of your address and the project type might be a good way to keep track if you'll be applying for multiple permits (for example – 123 Anywhere St– Pool Enclosure Permit).

Then select **NEXT** – Provide the **Location** where the work will be taking place. Change the municipality (dropdown menu in the upper right-hand corner to make sure you're on **Township of Scugog**).

Locate the property on the map.

There are three options to do it:

- Option 1: Using the municipal address of the subject property.
- Option 2: Using the roll number of the subject property.
- Option 3: Using a map to locate the subject property.

Option 1:

Start typing the address of the property into the text field. Cloudpermit provides you with a list of properties matching the address. Select the desired property from the list and click "Next."

Option 2:

Start typing it into the text field if you know the property's roll number. Cloudpermit provides you with a list of existing properties matching your typing. Select the desired property from the list and click "Next."

Option 3:

Click on the map to drag it. Zoom in and out using the "+" and "-" buttons on the top left of the map.

Once you have the correct location (it appears under the map).

Select the category and project type for your application. Please read the 'Good to Know' section if you require more information prior to selecting.

Next confirm which type your permit is for within Cloudpermit **For example Category under Residential:** Inground Pool Above ground Portable pool Hot tub Pond

Pool Enclosure Form

Next confirm Site Information through Cloudpermit:

- Is your Property a corner lot? Yes or No
- Is there a septic system on your property? Yes or No
- Is your property in a regulated Conservation area? Yes or No
- Is your property in an unassumed subdivision? Yes or No

Next confirm Fence and Gate Information:

- Wood Construction
- Chain Link Construction
- Metal Construction

List for required documentation will change for each type of permit but at a minimum:

- Approved Grading Plan (more details below)
- Site plan (please see details below)

Site Plan

The site plan drawing must contain the following information;

- i) drawing scale;
- ii) north directional arrow;
- iii) lot lines and dimensions;
- iv) existing and proposed construction dimensions;
- v) setbacks and lot lines;
- vi) any proposed changes to grade;
- vii) type of Swimming Pool to be installed;
- viii) safety measures to be taken during all aspects of construction.

Indicate on the Site Plan below, or **preferably on a copy of your survey**, the proposed location of the pool/hot tub with the setbacks from the pool/hot tub to your property lines.

Indicate on the Site Plan, or preferably on a copy of your survey, the location of all gates on your property.

Indicate on the Site Plan, or preferably on a copy of your survey, the type, location, and height of the proposed or existing fence. For Type see Fence and Gate Information on other side.

If you are on a corner lot indicate, the location and name of both streets (see example



below).

Grading Plan

In an effort to ensure new swimming pool construction is completed in accordance with Township of Scugog Standards and that the addition of a swimming pool does not negatively affect your or neighbouring properties, the Township is requesting that lot grading plans be submitted in support of most Swimming Pool Enclosure Permit applications. The lot grading plan should include the following;

- i) Existing topographic grading information within approximately 10 metres of the proposed pool location,
- ii) Proposed location and grading design in accordance with the Township of Scugog Development and Engineering Standards. Include any landscaping and pool accessory structures such as change rooms, pump shed, etc. Ensure any existing soak away or infiltration areas are considered in the design,
- iii) The plan must be prepared and signed by an Ontario Land Surveyor, Landscape Architect or Professional Engineer,
- iv) Should fill materials required for the project exceed 20 cubic metres, a Site Alteration Permit may also be required.
- v) A 0.6m (2 foot) undisturbed strip is maintained around the perimeter of the property.

Grading plans must be submitted to the Engineering Department prior to submitting your application for Swimming Pool Enclosure Permit. Once the lot grading plan has been reviewed and accepted by staff, it will form part of the documents required for the Permit.

A grading plan <u>may not</u> be required provided;

- vi) the swimming pool (including landscaping and decking) are not located closer than 10 metres to any lot line.
- vii) no stormwater management features such as drainage swales, a soak away pit or infiltration gallery are located in the area of the proposed pool.
- viii) minimum setbacks are maintained to the septic system in accordance with the OBC and written approval from Durham Region Health Department is received.
- ix) the existing drainage pattern of the lot will remain, and no additional drainage will be directed to neighbouring properties.
- x) no more than 20 cubic metres of fill is required for the project including all landscaping materials. Should fill materials required for the project exceed 20 cubic metres, a Site Alteration Permit may be required

Pool By-Law Requirements

- i) Nothing within 1 meter of the fence (exterior side)
- ii) Fence 1.2 meters from water's edge
- iii) Fence 1.5 meters tall
- iv) No gaps in fence bigger than 10 cm



- v) Maximum clearance between bottom of fence and grade 10 cm
- vi) Gate must be self-latching.

Zoning By-Law Setbacks

- i) Interior Side and Rear Yard ONLY
- ii) INTERIOR SIDE/ REAR YARD SETBACKS
 - Side lot line = 1.2 meters (4ft)
 - Rear lot line = 1.2 meters (4ft)
 - Primary building (house) = 2 meters (6.5ft)

Additional requirements

viii) A Building permit will be required for decks around above ground pools and hot tubs.

- Draining of pool water must be done entirely on same property. You cannot direct pool water onto adjacent properties or roadways.
- A Pool Permit Agreement, final lot grading certificate and permission from your builder will be required in all unassumed subdivisions.

Other required documents may include one or more of the following:

- Health Approval
- o Conservation Authority Approval
- Builder approval letter (unassumed subdivisions)

Step 2: Invite other necessary parties, such as property owner

Step 3: Complete your application, upload all required documents.

Complete the application data by:

- Scroll down to the application data section
- Your work is automatically saved, there is no save button
- There are red asterisk marks next to the form fields that are required to fill out
- Once you're done filling out the form, click the RETURN TO THE APPLICATION button at the top left of each form

Fill out the application data in the application workspace, identify application parties, and add attachments to the application, if needed.



• See instructions for adding required attachments.

Once all is done, click "Return to application."

Upload Attachments that are mandatory (Example **Detailed drawings site plan, Grading approval Certificate** and others as requested) by:

- Scroll down to the attachments section (Approved Grading Plan, Site Plan, etc. as required)
- Drag and drop attachments or select the "click here" button to identify the required files OR using the **"click here**" button to select them from your computer.
- Once they have uploaded, select the type of attachment, and then select done.
- Identify each attachment by selecting from a drop-down list of attachment type names
- If at any time you need to change or update the attachments (prior to submitting your application), you can delete (the little garbage cans) and upload again.

How to sign off and submit an application

Steps:

- Once you have finished your application, you must pay and sign it off before submitting it to the Township of Scugog.
- Only applicants can sign off on applications.

Step 4: Verify, Sign and Submit for review.

Sign Off on the Application

At this point, you are ready to **Sign Off** on the application, using the button at the top right-hand side of the page.



Review the items listed and indicate if they apply and/or you agree with the terms. Then click **"sign off application**."

Note that you can download a copy of the sign-off form at the top of the page.

Step 5: Once the completed application is received you will be invoiced and pay the fees either online or over-the-counter.

Click "Return to application" to enter the application workspace.

To pay the application right away, click "Continue to payment."

The "Fees and Payments" section shows you the total due.

Click "Submit upon payment."

You can pay the bill by:

- o Cash
- o Cheque
- Credit card (Note: with Visa (3.5 percent), Mastercard (3.5 percent), or American Express (3.5 percent). There is a 3.5 percent service fee payable to Bambora in order to use this service. Credit card is not accepted in the office only online.
- o Debit

After acknowledging the payment, the e document will be marked as paid. It means that the application is now submitted, and it moves to the review phase.

Refer to Fee schedule plus damage deposit + a fee if grading plan is required

Submit your Application



You will receive an email to confirm your application has been submitted, and you'll receive subsequent emails regarding its status. You will also receive an email advising you when the Pool Enclosure Permit is ready and if there is an additional cost.

Success - You have created your inspection request.

It moved to the Township of Scugog to dispatch it further to your By-law Inspector.

Step 6: Revise the application based on the feedback from the municipal authority.

Step 7: Watch for follow up emails to make sure the process keeps going.

Tips Dashboard - At any point, you can return to the "My Dashboard" page to see which applications you have made and if we are waiting on any information from you to process your application further. Delete - You can delete your application at any time by using the "Select Action" drop-down menu at the top of the page.
