# **DIRECTOR'S MESSAGE**



I am extremely proud of the achievements made by the Township of Scugog Public Works and Infrastructure Services (PWIS) department in 2022. PWIS was established to focus on maintaining and operating our assets in a strategic manner to ensure that they remain safe and available for use, at the best cost to the taxpayer. This annual report highlights the many accomplishments over the past year by this amazing team of people.

Our public works team were champions this year showing their dedication to the job when cleaning up from four extreme storms and other weather events that occurred in 2022. They worked long hours on weekends and holidays to ensure that our roads were save and usable. Storms in 2022 included a Significant Weather Event on January 17<sup>th</sup> with over 50 cm of snow, a State of the Emergency on February 20<sup>th</sup> (Family Day) to deal with high winds and drifting snow, an extreme windstorm (tornado and derecho) on May 21<sup>st</sup> (Victoria Day weekend) and a severe weather event on the days leading up to Christmas and on Christmas day with snow, high winds and drifting snow.

The continued efforts to increase the investments in rehabilitating and reconstructing our roads is showing positive results. With a focus on using the principles of asset management to invest in the right work at the right time and an increase in the number of projects, the overall condition of our roads increased for the first time in many years.

The completion of three new parks/ playgrounds in 2022 has enhanced our greenspaces and outdoor recreation opportunities. A new park was constructed in the Cawkers Cove subdivision, a new playground was installed in the Seagrave Park and at the Palmer's Park playground was replaced with a new inclusive playground.

Traffic calming efforts continued to address speeding concerns and enhance road safety across the Township. Initiatives including the installation of three new pedestrian crossings, new speed limit signs, continued use of mobile speed radar display boards, free lawn signs asking drivers to "slow down" and the prioritization of traffic calming locations.

I want to sincerely thank the entire team for all of their hard work and I look forward to the completion of the many exciting projects and initiatives underway for 2023!


## PWIS TEAM ORGANIZATIONAL CHART





## SERVICE REQUESTS

A significant part of PWIS Operations includes addressing service requests from Council, residents, businesses and identified as needs by staff. In 2022, staff implemented a new service request system to track and manage requests.

626 Total Service Requests in 2022 1,732 to date



Due to the very large volume of calls related to the tornado/ derecho on May 21, 2022, many of the tree related requests were not recorded in the CRM system. Similar to 2021, the most common requests continue to be related to trees, road conditions and ditches/ drainage issue.

## **ROAD MAINTENANCE**

Annual road maintenance activities are carried out year-round and include: salting/ sanding/ plowing for winter maintenance; patching; sweeping; patrolling to determine road conditions; annual inspections of signs, streetlights and sidewalks; ditching; brushing; mowing; tree maintenance; culvert installations and repairs; sign replacements; grading; applying dust suppressant; maintaining shoulders; etc.



Some of the recent efficiencies implemented in road maintenance include decreasing the use of cold mix for patching and increasing hot mix patching and large area patching/ repairs. The use of hot asphalt is much more effective than cold mix as:

- It is more pliable and will become more rigid once cooled
- It lasts much longer
- It reduces the number of times required to repair the same pothole which results in labour and material cost savings



The patching of large areas using hot asphalt is a new method being used by Township staff to provide a

temporary road repair until a more permanent road rehabilitation can be completed. Large area patchings were completed on eight roads in 2022 by Township staff to improve drainage, driveability and extend the life of roads.

## GRAVEL RESURFACING

The gravel resurfacing budget was once again increased in 2022, from \$825,000 to \$925,000 which allowed for the resurfacing of another 25.5 km of roads.



## WINTER MAINTENANCE

The Township of Scugog is responsible for the winter maintenance and snow clearing operations for 826 lane kilometers for roads, which is greater than the distance from Port Perry to Ottawa and back. All of this is completed by a day shift of 15 operators and a night shift of 2 operators. In addition, staff provide winter maintenance and plowing of 29 km of sidewalks and 15 parking lots.










While the usage of salt and sand varies depending on the weather, through the development of more efficient methods of salting and sanding of roads, the Township successfully decreased the usage of salt and sand by 34% and 67%, respectively, from the winter of 2017/2018 to the winter of 2021/2022.

## SERVICE LOCATES AND PERMITS







PWIS is responsible to review and approve permits for roads and related infrastructure. In 2022 the number of utility locate requests was similar to 2021 and the number of municipal consents and road occupancy permits decreased as the Bell Fibre to home program is nearing completion.


Permitting levels are expected to continue to be high based on new developments and anticipated rural fibre optic internet projects by utility companies.

The high level of permit activity requires significant staff time to review and issue permits.

#### CAPITAL BUDGET

Council and staff have been working to phase in increased investment in our assets through identifying efficiencies and cost savings, implementation of dedicated levies and grants from other levels of government. The dedicated Roads Levy was first introduced in 2014, and dedicated Vehicle & Equipment and Buildings & Facilities began in 2019. The Township has been successful in building much needed reserves to help address the Township's large deficit in infrastructure maintenance, repair and replacement.

Through these initiatives, investments into our roads and bridges have grown to an average of \$5.0 million per year over the past 5 years as compared to an average of \$3.1 million for the previous 5-year period (an increase of 63%). Based on the 2023 Capital Budget and 2024 to 2027 Forecast, over the next five years this investment is expected to grow to an average of \$7.4 million per year.



#### CAPITAL ROAD PROJECTS

2022 was a very busy year for road construction projects in Scugog. Approximately 11.5 km of paved or hard surfaced roads were reconstructed or rehabilitated. This brought the total length of paved/ hard surfaced roads that have been reconstructed or rehabilitated in the last five years to approximately 40 km.


## STATE OF THE INFRASTRUCTURE RESULTS

In the 2022, the Township's State of the Infrastructure Study was updated based on current road conditions to provide recommendations for short- and long-term asset management of the Scugog's road network.

The study found that the Township of Scugog road network has a current deficit of \$233 million dollars. The high infrastructure costs come from our expansive geography containing 192 kilometers of gravel roads and 221 kilometers of paved roads, which have been significantly underfunded for many years and as a result have been in serious decline.

The good news is that we are now seeing positive results and the overall road condition has improved as a result of the significant increase in investment in road maintenance made possible by the dedicated Roads Levy, identifying efficiencies and costs savings in other areas and successful grant applications with other levels of government. Some of the improvements can be seen from:

- The System Adequacy measure for the Township of Scugog road system is 57.3%.
   The System Adequacy has increased since the last review in 2019 of 49.9% but remains below the target of 60% (Figure 1).
- The Weighted Average Condition is 48.3 which again is an increase over the 2019 rating of 43.8 but below the recommended minimum of 70 (Figure 2).
- Good to Very Good roads for the entire system is 57.6% when measured by the Structural Adequacy (distress) metric which is a significant increase over the 2019 rating of 28.7%.





The study also recommended that continued increased investment is required to improve the condition of Township roads to an acceptable level and it is recommended that capital spending on roads be increased to the level of capital depreciation which is currently estimated at \$10.9 million.

PWIS staff also oversee the acquisition, maintenance and disposal of Fleet in all departments including Fire, Recreation, Parks, By-law and Animal Control.




Due to supply chain issues during the COVID-19 pandemic, the pick-ups are not expected to be delivered until at least the spring of 2023 despite being purchased early in 2022.

The Township has significantly increased the investment in the replacement of vehicles and equipment in the last five years and is forecasted to continue to increase the investment over the next five years. This has resulted in a decrease in repair costs and an increase in funds available for preventative maintenance of vehicles and equipment.



Annual expenditures for fuel varies each year based on a number of factors such as the number of winter events, number of emergency events and fuel rates. In 2022, fuel costs reached an all-time high with diesel fuel rates as high as \$2.26 per litre. As a result, fuel costs increased by 52% over 2021 totals.

## CAPITAL PARK PROJECTS

2022 saw the completion of three new parks/ playgrounds that have enhanced our greenspace and created new outdoor recreation activities.

#### **Cawkers Creek Park**

In October 2022 the first new park in many years was opened in the Cawkers Creek subdivision located on Sherrington Drive between Doctor Archer Drive and Glenhaven Court. The new park includes a playground designed for children from 18 months to 12 years of age; swing set complete with belt, tot and inclusive swings; basketball court; asphalt trails; shade pergola; benches; bike rack; privacy berms; open space and 57 newly planted trees.





## **FACILITY CAPITAL PROJECTS**

Major capital facility projects completed in 2022 included the full replacement of the sand dome at the Port Perry works depot at a cost of \$600,000 and the replacement of the refrigeration pipes and flooring on Pad 1 of the Scugog Community Recreation Centre at a cost of \$1,000,000.

#### TREE MAINTENANCE AND PLANTING

PWIS is responsible for the planting, removal and maintenance of trees within the municipal boulevards. In 2022, a major storm event occurred on Saturday May 21<sup>st</sup> that was determined to be a tornado and derecho storm. The storm resulted in massive amounts of downed trees and power outages across the entire Township.

Crews responded immediately to close roads where trees and power lines created hazards. Roads were reopened as hydro crews were able to restore power lines. It then took months for crews to clear the tree debris from roads and boulevards. Debris still remains on some easements. Overall, over one thousand loads of tree debris were collected, 200 overtime hours were spent on the cleanup and \$97,000 of contracted services were required to assist with the cleanup.

In addition to the storm cleanup 54 trees were planted in boulevards, 44 trees were removed prior to the storm and 50 more needed to be removed for safety reasons after the storm.



#### **LEAF** program



Once again, the Township participated in the LEAF (Local Enhancement and Appreciation of Forests) Backyard Tree Planting Program in 2022. This program is subsidized with the aim to establish large-growing native trees whose dense canopies can provide maximum environmental, economical and social benefits.

#### **Seedling Giveaway**

To promote planting of native trees, the Scugog Environmental Advisory Committee handed out **200 tree seedlings** on May 28<sup>th</sup> at the Port Perry Farmers Market.

# **Community Events**

Every year PWIS provides support for community events. In 2022, events were able to return in full force after the COVID restrictions from previous years. #### STORMWATER MANAGEMENT

#### Lake Scugog Enhancement Project



In 2022 PWIS staff, in partnership with Kawartha Conservation and the Scugog Lake Stewards, continued to make progress on the design, permitting and fundraising for the Lake Scugog Enhancement Project.

The Lake Scugog Enhancement Project (LSEP) is s an environmental improvement and dredging project for Port Perry Bay that benefits the whole lake. The purpose is to improve the recreational function of Port Perry Bay while creating a healthy nearshore habitat and providing water quality benefits. The range of benefits is broad including environmental, social, economic, tourism and recreation.

#### The project will involve:

- Constructing a 245 m long berm, 4 m wide on top and 18 m wide on bottom with a 3 m wide pedestrian path and four fishing platforms
- Dredging a total of 6.15 ha (20,693 m3) and placing the sediment behind the berm
- Dredging an additional 0.366 ha and disposing of dredgate offsite
- 1.065 ha wetland with a variety of terrestrial and aquatic habitat for turtles
- Installation of 2 to 3 oil grit separators

Funding for has been provided by the Township of Scugog, MSIFN, Region of Durham, various grants and Scugog Lake Stewards fundraising efforts. Construction of the oil-grit separators is expected to begin early in 2023. An additional \$1 million is needed before the dredging and wetland construction can begin.

## **GREEN INITIATIVES**

#### **Sidewalks**

The Township annual sidewalk replacement program continued in 2022 with \$100,000 invested in sidewalk replacements at 70 locations across Scugog.



#### **Trails**

Staff rehabilitated the multi-use trail next to the Victorian Village stormwater management pond that was damaged by the pond flooding prior to the repairs to the pond.

#### **Electric Vehicle Charging Stations**

The highly anticipated EV Chargers are now ready for use. There are two chargers at the Scugog Community Recreation Centre on Reach Street and two at the municipal parking lot in downtown Port Perry behind 181 Perry Street. Rates are \$1.50 per hour for the first 3 hours and \$4.00 per hour afterwards. Why does the rate increase after 3 hours? To encourage users to not park any longer than necessary to allow more people to use the charges.

## TRAFFIC ENGINEERING

PWIS has been actively working to improve safety for all road users (vehicles, cyclists, and pedestrians, etc.). Traffic safety/ traffic calming initiatives for 2022 are provided below.

#### **Pedestrian Crossings**

As the safety of pedestrians is of utmost importance to the Township, an important part of road safety is to provide more pedestrian crossings in high traffic areas. Three new pedestrian crossings installed as follows:

- An Intersection Pedestrian Signal (IPS) in the hamlet of Greenbank to provide a safe pedestrian crossing for Highway 7/12 at Cragg Road.
- A Pedestrian Crossover on Simcoe Street at Paxton Street. The crossing includes ladder crosswalk markings, overhead signage, flashing beacon and advance notice signage and pavement markings.
- A Pedestrian Crossover on Old Simcoe Road at Doctor Archer Drive The crossing includes ladder crosswalk markings, signage, flashing beacon and advance notice signage and pavement markings.

#### **Traffic Calming**

- Two mobile speed display boards were utilized at 16 locations across the Township to reduce speeds and provide data for DRPS to target excessive speeders on the road.
- 100 free lawn signs were provided asking drivers to "Slow Down".
- New reduced speed limits were implemented and signed across the Township.
- Traffic calming requests were evaluated and prioritized based on the Traffic Calming Implementation Protocol.

## **CROSSING GUARDS**

Crossing Guards play an integral part of student safety in the Township of Scugog. Based on the 2018 Crossing Guard Warrant Study, the Township's strives to provide crossing guards at 13 locations across the Township. However, hiring and retaining guards is an ongoing challenge and the Township has had to prioritize school crossings based on the number of students and one crossing was not covered for most of the school year.

As well, we have been limited with substitute Crossing Guards so some locations were not covered when a crossing guard was sick and trained Township staff were not available. When this happened, the Township posted the absences on Scugog's Facebook and Twitter pages.
